

NINETY (90) DAY LIMITED WARRANTY

Dream Islands (Waldi, LLC) warrants to the original purchaser that this product will be free from defects in materials or Workmanship for ninety (90) days from the date of original purchase. This warranty does not cover damages resulting from accident, negligence, or improper storage, care, maintenance, cleaning, service, use, or other causes not arising out of defects in materials or workmanship.

During this 90-day warranty period, the product will either be repaired or replaced at Dream Islands sole discretion and without charge to the purchaser other than return shipping. Purchaser should include a short and concise description of the defect, a check for \$8.00 to cover return packing and shipping (USA only). Please contact us for foreign shipping quotes. Clearly state the name and address of where the product is to be returned. The product must be returned with proof of the date of purchase to show that the product was within the warranty period and contact phone number must be provided.

The product must be returned by Purchaser to Dream Islands well packaged, preferably in the original box to avoid shipping damage. Dream Islands are fragile and Dream Islands will not repair or replace items damaged in shipping. We do ship USPS priority which insures package up to \$50.00 for loss or damage. For a fee Dream Islands, may, but is not required to, repair products after the 90-day warranty period has expired. Please email us to discuss out-of-warranty repairs and obtain a quote.
